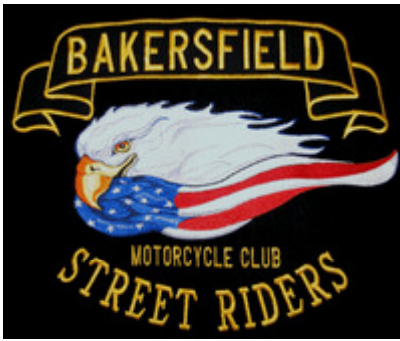

Bakersfield Street Riders Hold Harmless Agreement

This Hold Harmless Agreement is entered into by and between the Bakersfield Street Riders motorcycle club, its officers and its designated leaders, hereinafter "Promisors", and each individual dues paying member of the Bakersfield Street Riders motorcycle club, hereinafter "Promisees", on the date listed at the bottom of this agreement in Bakersfield, California.

Recitals

Promisors desire to provide organized motorcycle rides on scheduled dates, as mutually agreed upon between the parties. The intent of this agreement is to indemnify Promisors from any claims arising from and related to any motorcycle accidents that may occur during said organized rides, and to indemnify Promisees from any claims arising from and related to any motorcycle accidents that may occur during Promisee's participation in said organized rides.

Agreement

For Valuable Consideration, the receipt of which is hereby acknowledged, Promisors and Promisees agree as follows:

- Promisors will indemnify and hold harmless Promisees from any and all claims, actions, and judgments, including all costs of defense and attorney's fees incurred in defending against same, arising from and relate to Promisors' motorcycle rides. Promisees will indemnify and hold harmless Promisors from any and all claims, actions and judgments including all costs of defense and attorney's fees incurred in defending against same, arising from and related to Promisors' motorcycle rides.
- Promisees shall be entitled, in their reasonable discretion, to settle claims prior to suit or judgment, and in such event Promisors shall indemnify and hold harmless Promisees for any such claims paid, including Promisees' reasonable attorney fees incurred resulting from such claim. Likewise Promisors shall be entitled, in their reasonable discretion, to settle claims prior to suit of judgment, and in such event Promisees shall indemnify and hold harmless Promisors for any such claims paid, including Promisors' reasonable attorney fees incurred resulting from such claim.
- In the event any claim or suit is brought against Promisors or the Promisees within the scope of this agreement, each party shall pay for their own legal counsel chosen to defend such claims.
- This agreement shall encompass claims resulting from but not limited to (i) formation riding and (ii) non-formation riding. This agreement shall in no way prohibit Promisees' right to file claims against another individual who causes an accident which results in their injury or death. This agreement shall be interpreted under the laws of the state of California.
